1. Requirements of quality

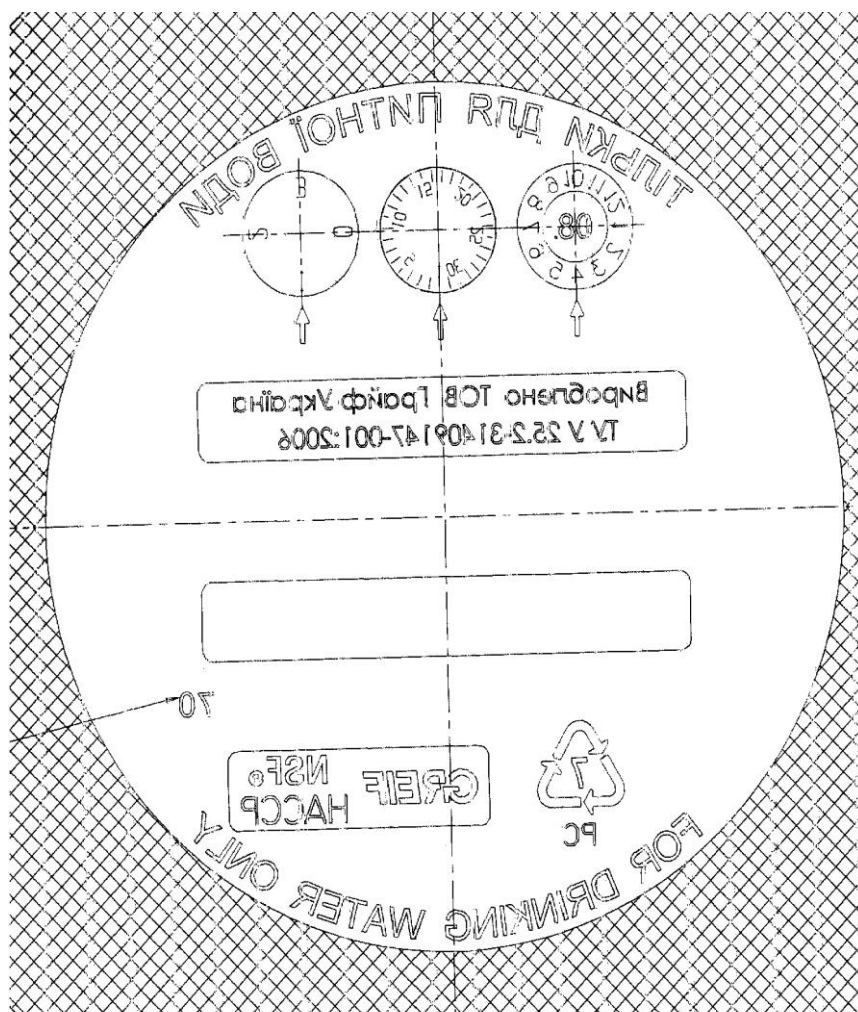
1.1. Appearance

- Clean, without damages and any contaminations
- Neck processing, neck trimming, smooth upper and bottom joints
- Light blue color, uniform, transparent.
- Careful labels application

2.2. Dimensions

- Bottle height 488 (± 3 mm)
- Bottle diameter 272 (± 2 mm)
- Bottle capacity 18,9L ($\pm 0,25\%$)
- Outside neck diameter 55,3 ($\pm 0,45$ mm)
- Bottle weight 770 (± 25 g)

Bottle's bottom has the following marks:

1. Date of production (day, month, year)
2. Shift number
3. Mold number
4. Mark of material recycling
5. Mark "For drinking water only"
6. Inserts with type of PCWB, volume in liters, reusable.
